- i) **Study on Bhoti Language:** Secretary informed the Commission about the detailed proposal received from Department of Indo -Tibetan Study, Vishwa Bharti University. The Commission agreed to the proposal and decided to send it to IFD for financial approval. It was also decided that Ms. Sulekha Kumbhare, Member, will be the Chairperson of the team who will conduct the study. However, she will not require any financial assistance for this purpose.
- ii) It was resolved by the Commission that the four NIC personnel working in the Commission should continue till the end of the financial year i.e. 2018-19 as their services are very much important for the day to day activities of NCM. After that the issue will be revisited. Similarly the services of Ms. Aamna Khatoon and driver working as despatch rider will also continue on a periodic basis at the rates approved by IFD on previous occasions.
