VIII. Agenda Item No.8: Tour report of ShriDhanyakamarJinappaGunde, Member, National Commission for Minorities to Madhya Pradesh from 12th December, 2024 to 13th December, 2024.

Recommendations:

- (i) The competent authority as defined under the Ancient Monument and Archeological Sites and Remains Act may kindly be advised to consider the issue in controversy and to grant permission for construction of Samoshana Mandir and Sahatrakut Mandir in Khajuraho by Jain religion people.
