- 21. Chairman desired that SoP may be developed on the functioning of the Commission which should include following points:-
- (i) What action has been taken & relief given and proposed course of action on sensitive issues viz. 1984 riots, anti-Muslim riots etc.
- (ii) Considering setting up of a Research wing for carrying out Research Studies which are scientific, positive in nature and the Govt. should be benefitted from such studies.

## Agenda No.18: Any other itemswith the permission of the Chairman.

- 1. With regard to the tours, Chairman gave the following directions:-
  - (i) Meetings should be held with State Government Authorities also.
  - (ii) Care must be taken to see if the States have been visited earlier or not. The intent being to visit States which have so far not been visited.
  - (iii) Before visit, report on issues from State Authorities may be called for.
  - (iv) No Member should be on tour beyond 15 days in a month and within a month, no Member should be in his/her Home State for more than a week.
  - (v) Recommendations/Observations must be recorded in the tour report.
  - (vi) During visits all the welfare schemes of the Govt. may be shared.
- (vii) With regard to the issue of Minority Certificates, the position given by MoMA & self-declaration certificate may be informed.
- 2. With regard to the Hearings, Chairman directed that cases be legally vetted & evidences called for, before holding a Hearing.
- 3. Functions/Seminars & Inter-faith meetings of all religions should be conducted frequently.
