

## Recommendations for the Effective Implementation of Safeguards for the Minorities and Action Thereon

8.1 Most of the recommendations of the Commission on the subject have already been mentioned in Chapter 4 under the Heading Tour Report of Chairman, Vice Chairman and Members of the Commission. These recommendations, *inter-alia*, contain the steps for safeguard for the minorities to be taken by State or Central Government. These recommendations are again categorically mentioned at Chapter 12 of the Report.

### 8.2 **Constitution of District Level Committee for Welfare of Minorities**

As per Prime Minister's New 15 Point Programme; a District Level Committee for Welfare of Minorities is required to be constituted, headed by the Collector/Deputy Commissioner of the District, with District Level Officers of the Departments implementing the programme, representatives from the Panchayati Raj Institutions/Autonomous District Councils, and three representatives from reputed institutions dealing with Minorities. However, it has come to the notice of National Commission for Minorities that in many Districts of the country, District Level Committee (DLC) for Minorities are yet to be formed. These DLC's are expected to monitor and address the issues pertaining to the Minority Communities.

NCM has directed all Chief Secretaries to give necessary instructions to all Districts in the State for setting up of District Level Committee.

### 8.3 **Paucity of Graveyards**

It has come to the notice of National Commission for Minorities that people of Minority Communities especially Muslims & Christians are facing hardships while burying their dead as there is a great paucity of land for burial. Moreover, the existing graveyards are being encroached and illegally occupied by the miscreants creating a menace for the burial.

NCM has requested to all Chief Secretaries to free the graveyards from encroachment and illegal occupation by the miscreants. It has also been requested to incorporate the graveyard lands in your City Development Plan in all districts as per population of that district.

### 8.4 **Representation of each minority communities in the State Minority Commissions**

The National Commission for Minorities has been receiving representations from various Minority Communities that they are not being represented in the State Minorities Commissions. The Commission has, therefore, requested all State Governments that Members of each notified minority communities should be represented in the State Minorities Commission.

## A Report on the Specific Complaints Regarding Deprivation of Rights of and Safeguards for the Minorities and Action Thereon

- 9.1 Under the National Commission for Minorities Act, 1992, the Commission has been entrusted with the responsibility of looking into specific complaints regarding deprivation of rights and safeguards for the minorities and to take up such matters with the appropriate authorities. The Commission received 1871 complaints during the year 2018–19. Out of these complaints, 1344 were from the Muslim community/organizations/institutions, 136 from Christian community, 161 from Sikh community, 46 from Buddhist community, 03 from Parsi community, 63 from Jain community and 118 were from those which did not belong to any of the notified minority communities.
- 9.2 82 complaints pertained to educational matters, 149 were related to service matters, 1039 were regarding law and order problems, 12 concerned economic matters, 1 were related to cultural rights, 82 were related to religious rights, 66 were on Waqf matters and the remaining 440 complaints were of miscellaneous nature. A statement showing State-wise and subject-wise break up of complaints is given at **Annex–I**. Similarly, State-wise and community-wise break up of complaints is given at **Annex–I(A)**. These complaints were examined in the Commission and action was taken as per the prescribed procedure of the Commission. Cases in which hearings were held and outcome thereof are given in **Annex–II**.

## Matters Referred to the Commission by the Central Government

### 10.1 Request for inclusion of Sanamahi religion in the list of minorities.

Ministry of Minority Affairs asked for specific comments of NCM on a request received from Committee on inclusion of Sanamahi Laining in the list of minority religions of India in the list of notified minorities in the country under Section 2 (c) of NCM Act, 1992. It has been mentioned in the representation that Sanamahi religion is one of the oldest religion in Manipur and there are about 2.2 lakh population in the State follow this religion. The issue of inclusion of Sanamahi religion as Minority in the State was raised in Manipur Assembly in 2011. However, no decision taken by the Government of Manipur. It seems that the followers of Sanamahi are found only in Manipur in India.

### 10.2 As per Section 2 (c) of NCM Act, 1992, minorities are notified by the Government i.e. Ministry of Minority Affairs. Therefore, the power to recognise a community as minority community vests with the Central Government.

## Administrative set up of the Commission (Including Finance and Accounts and Implementation of the Official Language)

- 11.1 Shri J.R.K. Rao, IAS (1985 Batch), Secretary, NCM superannuated on 28.02.2019. Shri Prashant Sukul, IDAS (1982 Batch) joined as a Secretary on 01.03.2019 in National Commission for Minorities.
- 11.2 As on 31.3.2019, the total sanctioned strength of the Secretariat of the Commission was 86. The list of the sanctioned posts and the vacancies is given in **Annex III**.
- 11.3 During the year, quarterly meetings of the Departmental Official Language Implementation Committee were held regularly. The Hindi 'Pakhwada' was organized in the Commission and a number of contests were organized among the employees.

**12.1 Chairman***For State Government*

- (1) During the visits of Chairman and Members of NCM to various parts of the country, it has been observed that the minorities have lack of awareness about the benefits of the central schemes under PMJVK. Therefore, State Governments may be requested to instruct Departments of Minority Welfare to hold special camps wherein people from the minority communities are invited to participate and informed about welfare schemes.
- (2) Wider publicity may be given to these special camps in local print and electronic media.
- (3) Concerned departments of the states may print their own material in local languages for the benefit of the minority population.
- (4) Grievances regarding allotment of houses under Pradhan Mantri Awas Yojana, USTAAD, Scholarship Schemes, Seekho aur Kamao, Maulana Azad National Fellowship Scheme etc. may be taken up and efforts should be made to resolve/forward the same in these camps.
- (5) District Magistrates may be asked to ensure presence of all the concerned officials during the meetings undertaken by the Chairman and Members of the Commission.
- (6) It has been seen that majority of the complaints/representations received during public hearings/Jan Sunwai related to State Waqf Boards. Therefore, CEOs of all the State Waqf Boards should be made accountable for looking into these matters and taking corrective measures for the resolution of the same.

**Vice Chairman****12.2 Karnataka***For State Government*

- (1) Government of Karnataka may appoint a Buddhist Member in the State Minority Commission.
- (2) Government of Karnataka may take appropriate action to issue Buddhist religion Certificate to the Buddhists in Karnataka.
- (3) Government of Karnataka may recognise the education in the Buddha Viharas and issue Certificates to the students.

## 12.7 Mahe

### *For State Government*

- (1) Promotion of Sports may be included in the Pradhan Manthri Jan Vikas Karyakram (PMJVK).

## Shri Sunil Singhi, Member

### 12.8 Raipur, Rajim, Jagdalpur & Rajnandgaon, Chhattisgarh

#### *For State Government*

- (1) Construction of hostels at each District Headquarters for the female minority students belonging to rural areas.
- (2) Appointment of Buddha and Jain community Members in Chhattisgarh Minority Commission.
- (3) A large number of Buddha relics and fragmented sculptures are lying unprotected at various places. Steps may be taken to allot a dedicated place for conservation of these relics and sculptures.
- (4) A Buddhist community Member may be appointed on the Chhattisgarh Minority Commission as well as Block and District level minority welfare committees.
- (5) Mahaveer College of Ayurvedic Science, Rajnandgaon request for grant of minority education institution status to their College is pending which may be expedited.

### 12.9 Mundra, Lakhpur & Bhuj Talukas in Kutch, Gujarat

#### *For Central Government*

- (1) A direct train should be introduced from Bhuj/Gandhidham to Amritsar City instead of Jalandhar.
- (2) The suitable route of the train should be via Jodhpur, Bikaner, Suratgarh, Bhatinda, Firozpur, Jalandhar and Amritsar.
- (3) The concrete steps should be taken to increase the rail passenger traffic between Kutch (Gujarat) and Punjab.

### 12.10 Ahmedabad, Bharuch & Nadiad (Kheda), Gujarat

#### *For Central Government*

- (1) Wide publicity of Minority Welfare Schemes of the Indian Government should be done at grassroot level.
- (2) The rate of scholarships under various minority schemes should be enhanced.
- (3) The eligibility income limit of parents for getting benefit of various minority welfare schemes should be enhanced.

### 12.11 Indore, Badnagar, Dhar, Ujjain and Shajapur, MP

#### *For Central Government*

- (1) In order to provide food to poor people, the Jain Community runs a number of Bhojanshalas across the country on 'No profit no loss'. The steps should be taken by the Government to reimburse the GST, paid by the Bhojanshalas on purchase of raw material for preparation of food.





*For State Government*

- (1) Jain Pathshalas, being run across the country, should be provided grants on the lines of Madarsas.

**12.17 Ranchi**

*For State Government*

- (1) Since Parasnath Sammet Shikharji Parvat in Giridih District of Jharkhand is the world's holiest and revered pilgrimage place of Jain religion, concerted efforts should be made to keep its sanctity intact.
- (2) The concerned officers of Jharkhand Government may discuss the matters regarding development and provision of infrastructure facilities as well as security of pilgrims at the pilgrimage with the Trustees in advance and implement the suggestions so received on priority basis.

**12.18 Modasa, District Aravalli, Gujarat**

*For State Government*

- (1) Arrangements should be made to provide free coaching facilities to the aspiring minority candidates under Naya Savera minority welfare scheme of the Government of India.
- (2) Awareness campaign should be organized in minority concentration areas to impress upon parents for enrolment of their daughters in Kasturba Gandhi Balika Vidyalaya for studies.
- (3) Arrangements should be made to publicize concessional credit schemes of the Government of India for minority entrepreneurs.

**12.19 Chhota Udepur District, Gujarat**

- (1) Arrangements should be made to provide free coaching facilities to the aspiring minority candidates under Naya Savera Minority Welfare Scheme of the Government of India.
- (2) Awareness campaign should be organized in minority concentration areas to impress upon parents for enrolment of their daughters in Balika Vidyalayas for educational empowerment.

*For Central Government*

- (1) Arrangements should be made to publicize concessional credit schemes of the Government of India for minority entrepreneurs.
- (2) The rate of scholarships under various minority schemes should be enhanced.
- (3) The eligibility income limit of parents for getting benefit of various minority welfare schemes should be enhanced.

**12.20 Jodhpur, Rajasthan**

*For State Government*

- (1) Camps should be organized in the areas having large number of minority communities to spread awareness about various minority welfare schemes of the Government of India.



- (2) Need for providing modern education in all Educational Institutions including Madarsas.
- (3) Peace Committee should be constituted, if not already in place, by the district authorities, and nomination of representatives of all minority communities into the Committee.

## 12.21 Shree Pavapuri, Sirohi, Rajasthan

### *For State Government*

- (1) During Jain community religious processions, certain unsocial elements pass obscene comments about Jain saints. It is recommended that local administration and police should take all security measures for providing protection during such religious functions/processions in order to avoid unpleasant situations arising out of it. Video coverage should also be done for such processions, in order to identify such anti-social elements and book them for suitable legal action.

## Ms. Sulekha Kumbhare, Member

### 12.22 Nagpur

#### *For Central Government*

- (1) Awareness campaign is required for the publicity of other minority communities like Christian, Buddhists, Jain, Sikh, Parsi besides Muslims are also under minority.
- (2) To establish the Haj House at Nagpur.
- (3) Formation of Waqf Board for extending justice to the minorities.
- (4) To recommend the Civil Aviation Minister, GoI, to start flights from Nagpur International Airport to Bodhgaya, Thailand, Srilanka, Myanmar, Saudi Arabia.
- (5) Recommend the Railway Minister to start Super Fast Trains from Nagpur to Bodhgaya, Bihar.
- (6) Services of National Highways and Telecommunication services may be provided to required districts.

#### *For State Government*

- (1) Formation of minority committees at district/region/state-wise for the implementation of minority welfare schemes.
- (2) After every three months state-wise reports and follow-up action be required to be submitted by Secretary, State Minority/Welfare Ministry to NCM.
- (3) Collector be directed to take drive in order to facilitate the issue of caste certificate since the minorities are deprived of the benefits of welfare schemes.
- (4) Mid-day meal schemes should be implemented for minority schools and Madarsas.
- (5) Centres for free coaching classes for preparation of competitive exams be established for minority students at district level.
- (6) Small Scale Manufacturing and Production units be established at Taluka and District level for the minorities to make them economically empowered. 4% of the manufactured products be purchased by the government agencies which will make easy available market for them.





- (7) Since majority of the government departments are converted into private sector but the reservations in government sector is not followed in private sector, therefore, it is necessary to have at least 20% of reservation for the minority community in private sector services also.
- (8) The minority people working in private sector on contract basis are required to be given all the benefits on par with the permanent employee working in government departments.

## 12.23 Bihar

### *For Central Government*

- (1) Security of Mahabodhi Temple is the most priority; hence an advanced Security System is required to be installed for the overall security of the Mahabodhi Temple which will replace the metal detector procedure right now adopted for screening the people.
- (2) Protection of Mosques, Churches, Buddha Viharas, Gurudwaras, Jain temples and other religious places of minority communities.
- (3) Preservation of ancient Buddhist monuments like Mahabodhi Vihar, Buddha Gaya etc.
- (4) Buddhist Tourist Circuit to be developed with inclusion of more monasteries.
- (5) Suggestion regarding broadcasting Buddhist religious scriptures may be taken up with the Minister for Information & Broadcasting.
- (6) The International Convention Centre with Buddhist Theme Park is required to be constructed for exchange of language, culture, and art between India and other Buddhist countries like Japan, Taiwan, Thailand, China, Myanmar, Cambodia, etc.

### *For State Government*

- (1) Schools having majority of minority students should be given the status of Minority Institutions and be given the benefits and financial assistance on par with Madarsas.
- (2) The students belonging to minority community but are economically handicapped be provided scholarships, uniforms, books under the minority schemes.
- (3) Minority hostels are required to be established at Taluka level or district level for minority students by the Ministry of Minority Affairs.
- (4) Implementation of low cost housing schemes with provision of subsidy for minorities.

## 12.24 Himachal Pradesh

### *For Central Government*

- (1) Recommendation for reservation of land for graveyard for minority community in Development Plan in every Taluka and District.
- (2) There is a demand that since Pali is taught in 50 colleges and 100 universities, it should be also available as an optional subject for UPSC which was already available from 1981 to 1993 though it was not included in 8<sup>th</sup> Schedule.
- (3) Bhoti language is the regional language of most of the part of the north-east for the Buddhist people. The script of Buddhism to a large extent is also available in Bhoti language. The Bhoti language is taught in schools in north east but it has not been yet recognised as a regional language. Demand for Bhoti language as a Third Optional



Language in the schools and colleges in North-east area of the country is required to be recommended and considered by the Government.

- (4) It is a long standing demand of formation of Pali Academy on par with Urdu Academy which is recommended.
- (5) Training centres for different trades under PM's 15 Point Programme be established at Taluka and District level.
- (6) Self Employment Centres are required to be established specially for self-help women groups belonging to minorities in order to make the minority women economically empowered.

#### *For State Government*

- (1) Excavation of religious monuments in India done by Archaeology of India should be preserved in Museum/Art Gallery.
- (2) At least 20% of the minority students be given admission in CBSE and central affiliated schools and also waive the fees to minority students who are economically handicapped.
- (3) The minority students living in rural areas be provided hostel facility in urban areas to avail better education.
- (4) The Library and E-library is required to be established at Taluka and district level to provide educational atmosphere for minority economical weaker students.
- (5) Installation of Water Supply System and purification system as the Buddhist monks are required to bring water from the distance of 500 to 700 metres.
- (6) Installation of Solar Heating System in Monasteries under the tourist development work or Minority Welfare Department.

#### **12.25 Vada Dasturji Khurshed K. Dastoor, Member**

- (1) **Palghar (Maharashtra) Issue:** This petition is also along pending issue received from Mr. Percy Master and Ms. Farzan Mazda of Dahanu – Golwad of western Maharashtra regarding the long issue of harassment and encroachment of land of Zoroastrian (Parsi) farmers of District Dahanu. They are facing problems with the tribals now as they are placing boards and claiming autonomy of the entire area in violation of extent Government orders and instructions discarding the legal ownership of the subject lands. This problem is attaining uncontrollable situation by peaceful means and the legal occupants are living under constant threat and fear on daily basis. NCM should take up this issue again seriously with all the nodal authorities in the Centre and State. In the meantime, they have also requested for round the clock Police and Civic authorities bandobast at the place so that the innocent people are not made to suffer the insecure and life threatening conditions prevailing over the area. Simultaneously, a strict warning should be issued to the local mafia were actually trying to instigate the innocent farmers living in the periphery of the Dist. Dahanu area. They should also be told not to take the breach the law and avoid violent procession on their part.
- (2) **Issuance of Minority Certificate:** As MOMA has issued a letter stating that there is no requirement of minority certificate for all the minority community members; one can use self-declaration certificate also. But people are unaware about this and still facing difficulties in getting their minority certificate. NCM should forward a letter to



the concerned State and instruct all the authorities and nodal agencies in each and every district to accept the self declaration certificate from the member of the minority community.

- (3) **District Dang (Gujarat):** In Dist. Dang The Minority Cell office has not yet been created; as the tribal people still facing difficulties to travel up to Valsad for their office needs. NCM should write a letter to the concerned authority/District Collector for creation of Minority Cell.
- (4) All Parsi religious places should be declared as Iconic pilgrimage places as it should be developed international standards.
- (5) Scholarship amount could be enhanced across all educational streams and categories to enable the beneficiary candidates to gainfully utilize the amount for furtherance of their educational pursuits.

### **Shri Manjit Singh Rai, Member**

#### **12.26 Pathankot, Punjab**

*For State Government*

- (1) Financial assistance for ITI Pathankot under Prime Minister's New 15 Point Programme for the welfare of minorities.
- (2) Hindi, Punjabi and English teachers be provided in the Madarsa in Tehsil Sujanpur, Village Souli Bholi, for girls.
- (3) 2 acres land be allotted for Qabristan for Christian community within the Municipal Corporation limit, Pathankot.

#### **12.27 Bathinda, Punjab**

*For Central Government*

- (1) In Padho Pardesh scheme, the income of student's father and mother should be increased to 8 lakhs so that maximum students can get benefit of the scheme.

*For State Government*

- (1) Infrastructure for minority community office at District level and financial support be provided by the State Government.

#### **12.28 Ludhiana, Punjab**

*For State Government*

- (1) Administration to issue Minority Certificate to Jain community as they have been declared minority community by Government of India.
- (2) Graveyard for Christian community of Jalandhar and Batala to be provided.
- (3) Employment for son of Smt. Saleena w/o Shri Rajik Masih on compassionate grounds in Punjab Home Guard may be provided.

#### **12.29 Shillong, Meghalaya**

*For Central Government*

- (1) Force be deployed to control the situation and may not be removed before proper peace is restored in the area.



### 12.30 Ambala, Punjab

#### *For Central Government*

- (1) The Aanganwari centers name be changed as 'Play Ways School'.

#### *For State Government*

- (1) Budget be allocated for the scheme "Apki Beti Hamari Beti".
- (2) Ensure the availability of Punjabi teachers in schools/colleges.
- (3) Setting up of State Minority Commission.
- (4) The Khalsa school and the Gurudwara in the school premises should be opened.
- (5) Fund to be allocated to build the Anganwadi centres in Ambala, Haryana.

### 12.31 Hoshiarpur, Punjab

#### *For State Government*

- (1) Buildings should be constructed to provide shelter to the women belonging to minority community who are affected by domestic violence.
- (2) Rs. 400/- to be given to all minority students studying from Class I to VIII in lieu of uniform, in line with those provided to SC children.
- (3) Benefits of Shagan schemes should also be provided to minority communities.
- (4) Land for graveyard (Qabristan) should be allotted and also be freed from any encroachment.

### 12.32 Mathura, Uttar Pradesh

#### *For Central Government*

- (1) Some Banks are not giving credit to minority people under "Credit Link Subsidy Scheme". All banks may be instructed to give credit to the minorities.
- (2) The name of Anganwadi should be changed and basic infrastructure including land, building, water, electricity etc. should be provided to these centers.
- (3) Maintenance and expenditure for Kasturba Gandhi Vidhyalaya (KGV) should be provided to all centers in the country including U.P.

#### *For State Government*

- (1) The special data prepared by Government of Uttar Pradesh to include people not covered in 2011 census for benefit of Awas Yojana has been completed but nothing has been done so far. It may be looked into.
- (2) Government of Uttar Pradesh is giving Rs. 100 as old age pension whereas Central Government give Rs. 300. Disparity should be removed.

### 12.33 Faridkot, Punjab

#### *For State Government*

- (1) All the State Governments should ensure that all the guidelines issued from the Central Government be sent to all districts in their regional language.



#### **12.34 Patiala, Punjab**

*For Central Government*

- (1) Banks should help to flow credit to minority community students to set up their own industry.

*For State Government*

- (1) All the Departments and offices of Punjab Government including Deputy Commissioner Office, Employment Office, District Education etc. should display boards in which all schemes related to minority community be mentioned for the awareness of minorities.

#### **12.35 Mohali, Punjab**

*For State Government*

- (1) Action to be taken on FIR filed by Shri Chota Khan s/o Shri Deva Khan r/o Gharoli, Tehsil Kharar, Distt. Mohali, Punjab.
- (2) To release fund to Bankfinco, Mohali (SAS Nagar) under PM's New 15 Point Programme.
- (3) To settle the loan of Sh. Sarmukh Singh s/o Shiv Ram, village Jadhot.

#### **12.36 Panipat, Haryana**

*For State Government*

- (1) To set up State Minorities Commission in Haryana State.
- (2) Waqf property being illegally sold by Waqf Board officials. State Govt. to look into the issue.

#### **12.37 Faridabad, Haryana**

*For State Government*

- (1) To provide the possession of land to build up the Khalsa school.
- (2) To provide the possession of land to build up heritage center in the name of Baba Banda Singh Bahadur.
- (3) To provide the land along with the Gurudwara building.

#### **12.38 Agra, Uttar Pradesh**

*For State Government*

- (1) District level Committee has not been formed by District Magistrate, Agra. It may be formed at the earliest.

#### **12.39 Gurugram, Haryana**

*For State Government*

- (1) The dumping of wastage by Corporation near 150 year old Jain Mandir and Christian Church/school are creating nuisance. Necessary steps be taken.
- (2) To take necessary action against the accused Gujjar people who have attacked Khateek Sikh community people at Village Sohna.





#### 12.40 Sonipat, Haryana

##### *For State Government*

- (1) An officer at district level to deal with problems of minority community people must be appointed.
- (2) Boundary wall of village Kakaroai graveyard be built.
- (3) Action to be taken against those people who destroyed boundary wall of patla village graveyard and remaining boundary wall of the graveyard be completed as early as possible.
- (4) Benefits may be given by colleges/institutions to children of minority communities.
- (5) There may be reservation for minorities in employment.

#### 12.41 Palwal, Haryana

##### *For Central Government*

- (1) A memorial Smarak be build up at Palwal for those people who have sacrificed their lives from 1857 to 1947.

#### 12.42 Mahendragarh (Narnaul), Punjab

##### *For State Government*

- (1) Though Punjabi is the second language in Haryana, there is only one post of Punjabi teacher in the District. More Punjabi teachers may be posted.
- (2) Many Sikh families have left Mahindragarh District. The reasons as well as data may be investigated.
- (3) To protect the 5 acre land possessed by Sikh people in the district from land mafia.
- (4) People residing within Lal Laqir area are not getting loans under PMAY. The issue may be looked into so that poor minority people can build their houses.

#### 12.43 Gorakhpur, Uttar Pradesh

##### *For State Government*

- (1) Provide alternative land for the worship places, which has been removed.
- (2) To remove the discrimination against the minority community in the issue of installation of inter-locking system in ward No. 43 of Gorakhpur.
- (3) To provide benefits of loan waiver scheme to the Buddhist community in the District.
- (4) To provide basic facilities to Buddhist people to visit their religious places.
- (5) Provide arrears to Madarsas teachers.
- (6) To include Madarsas under Swachhta Abhiyan and construct toilets.
- (7) To issue the Minority Certificate online and simplify the procedure.
- (8) To provide protection to the Gurudwara land from the land mafia.
- (9) Issuance of certificates to students of mini ITI run by the Madarsas, which shall be recognized by other Institutions.
- (10) Issuance of Scheduled Caste Certificate to Rai Sikh community.





- (11) The seats may be reserved for Sikh community in Municipal Corporations and other nominated boards.
- (12) The compensation may be provided to the families affected in the 1984 riots.
- (13) Issuance of OBC Certificate to Goldsmith (Sunar) Sikh community.
- (14) Action to be taken on the FIR lodged against Dharmendra Bharti.
- (15) Ban on procession for support of mob lynching culprits.

#### **12.44 Aligarh, Uttar Pradesh**

##### *For Central Government*

- (1) Banks insist opening of bank account of every individual of a Self-Help Group (SHG) so that they can avail the facility of loan under SHG programme. Also banks insist that one member from one family may be a member of SHG. These conditions may not be insisted as these will defeat the purpose of forming SHGs.

##### *For State Government*

- (1) Minority Certificate to be issued to Sikh community who belong to Gujjar, Jatt, Ravidas, Nai and Yadav etc. castes.

#### **12.45 Moga, Punjab**

##### *For Central Government*

- (1) List of beneficiaries of Pre-Matric and Post-Matric scholarships be sent to District Education Officer while transferring the amount in their respective bank accounts.
- (2) Bank accounts of beneficiaries of scholarship should not be closed due to non-operational reason.

##### *For State Government*

- (1) The blood tests of the children should be done on regular basis under ICDS schemes and accordingly they may be provided the medicine.

#### **12.46 Gurdaspur, Punjab**

##### *For State Government*

- (1) Enquiry to be done regarding non-utilization and misuse of funds released by the Ministry of Minority Affairs under MSDP for Gurdaspur, Dhariwal, Kalanour and Dera Baba Nanke.

#### **12.47 Shaheed Bhagat Singh Nagar, Punjab**

##### *For State Government*

- (1) To issue Minority Certificates to all the notified minority communities in a hassle free manner.
- (2) The land for graveyard be provided to Muslims and Christians.

#### **12.48 Rewari, Haryana**

##### *For State Government*

- (1) Hand over the idol found out during the excavation to the Jain community to be kept in the Jain temple.



#### 12.49 Agra, Uttar Pradesh

*For State Government*

- (1) The road leading to Gurudwara Sahib Mai ka Taal is very narrow and people coming from all the part of the countries to seek blessings are facing problem. The leading road may be widened.

#### 12.50 Amroha, Uttar Pradesh

*For State Government*

- (1) Order of Government of Uttar Pradesh dated 12.03.2018 regarding appointment of teachers in minority secondary schools may be revisited and the management of the minority institutions may be given more autonomy.
- (2) Punjabi language be declared third language in Government schools, If more than 30 children are willing to learn Punjabi and teachers for the same may also be appointed.
- (3) Schools and Colleges especially for women be established in minority dominated districts, on a priority basis.

#### 12.51 Jhansi, Uttar Pradesh

- (1) Self-declaration of income of parents may be accepted in the place of income certificate for scholarship as parents are facing problems to obtain income certificate.
- (2) List of agencies under the Scheme Nai Roshni, Learn and Earn, Maulana Azad, Ustad, Pado Pardesh or any other schemes may be provided to the Districts.
- (3) Hard copy of scholarship form in merit cum means scholarship schemes may be provided to District Minority Welfare Officers for verification.

*For State Government*

- (1) Demands of Arabic Madarsa Teachers Association, Jhansi may be examined and considered.

#### 12.52 Lalitpur, Uttar Pradesh

*For State Government*

- (1) Appropriate action as per law to be taken against two NGOs namely (i) Uras Committee of Baba Sadan Shah and (ii) District Muslim Association by the district administration.
- (2) Action to be taken against police officers who are not allowing possessions of land No. 1782/1 belonging to Varni Jain College Samiti and an officer outside from district Lalitpur to be appointed to look into the matter.
- (3) Jain teachers who were teaching religious rights to Jain children on the pattern of Madarsa may also be given salary like Madarsa teachers.

#### 12.53 Sirsa, Punjab

*For State Government*

- (1) Funds be given to Minority institutions run by Kalgidhar Society.
- (2) Loans to minority community people be given without interest as given to people of Scheduled Castes.
- (3) Post of teacher at Kasturba Gandhi Balika Vidhyalaya, Village Fatehpuria district, Sirsa and Minority Welfare Officer of Sirsa may be filled.



### 12.54 Mewat, Haryana

#### *For State Government*

- (1) Most of the posts of Urdu teachers and Maths teachers are lying vacant in the Nuh district, due to which children of this district are facing big problem. Vacant posts may be filled up.
- (2) For minority community children, a University be established in Nuh district.
- (3) Haryana Gramin Bank's RTGS is not working properly due to which students who have opened their accounts with Haryana Gramin Bank are not getting their scholarship and Bank is sending amount back to concerned department. This may be looked into.
- (4) Nuh district, more than 50,000 people from Muslim community are drivers. But as per the New Motor Vehicle Act, those people are facing big problems as they cannot renew their driving license as according to the Act, minimum qualification is Matric, whereas they are totally illiterate. Some relaxation may be given in educational qualification to get renewal of their driving licences.
- (5) Crossing at Bombay Express Highway be built at Nuh to Hodal road and Nagina to Punhana road, so that people can get benefit of this road and it will be better for the development of Nuh district.
- (6) NH 24 8A from Nuh to Alwar be extended with four lane.

### 12.55 Yamunanagar, Haryana

#### *For State Government*

- (1) There is no bridge on Sukra river for which the people of minority community of 8-10 villages have been facing big problem, so a bridge be build up on Sukra river.
- (2) A Community Hall be built in the village of Wasava Singh for minority people.
- (3) District level religious educational institutions be established at Yamunanagar in which the children of Sikh community can get religious education along with kirtan, tabla and other instruments which are related to Sikh community.

### 12.56 Rohtak, Haryana

#### *For State Government*

- (1) Punjabi and Urdu may be made a compulsory subject in Haryana as was there before 1966 in Haryana.

### 12.57 Kaithal, Haryana

#### *For State Government*

- (1) Punjabi language be declared as the second language in Haryana.
- (2) Minority Commission be established in Haryana.
- (3) Funds be allocated for two blocks namely Gulha and Seewan block under PMJVK for building of classroom, toilet, laboratories, etc.

### 12.58 Kullu, Himachal Pradesh

Compensation to victims for their loss in 1984 and 1987 may be provided.

### 12.59 South-East, Delhi

#### *For State Government*

- (1) DM to hold community level meeting with registered RWAs in Minority Concentrated Areas.
- (2) SDMs to visit the Minority Concentrated Areas once in two months to resolve the pending issues.
- (3) The police authorities to post one or two Beat Constables in front of schools during the time of dispersal of students.

### 12.60 South, Delhi

#### *For State Government*

- (1) DM/ADM/SDMs to hold community level meeting with registered RWAs in Minority Concentrated Areas.
- (2) DCPs to visit the Minority Concentrated Areas once in two months to resolve the pending issues.
