➤ ***Solution adopted by the Govt. of Assam Welfare of Minorities & Development Department as mentioned below.–***

Sl. No	
1	The Govt. of Assam Welfare of Minorities & Development Department has constructed 21 Nos. of Model Residential School and 15 Nos. of ITI in Assam and handed over to Education Department for providing educational facilities belonging to the students of minority communities.
2	The Govt. of Assam Welfare of Minorities & Development Department has implemented & being implemented employment generation schemes like– GNM, ANM, BSc Nursing, B. Pharm, D Pharm, DMLT, BMLT, DTP, BPT, ICU Technician, O.T. technician, Dialysis Technician, Fashion design, Air Hostess, Automobiles Technician, Electrician, Plumber, Masonry, Beauty Culture course etc.
3	Coaching for entrance examination – UPSC, APSC, Medical & Engineering entrance, Banking, Railway clerical entrance course.

Suggestion

Sl. No.	
1	Implementation of agricultural (Horticulture/ Sericulture/ fisheries/ Poultry/ Dairy farming etc.) focused scheme in the minority concentrated districts will promote self-reliance among minority communities resulting in socio economic progress.
2	Construction of Girls Hostel and Boy's Hostel in every State for staying poor minority communities' students & working women.
3	Emphasis may be given on skill oriented schemes for economic empowerment.
4	Conduct studies, research and analysis on socio-economic and educational development of minorities.
5	Re-open the scholarship schemes.
6	The Govt. of Assam may establish more schools and improve infrastructure, offer Coaching and skill based education in minority areas.

Sl. No	
7	Reservation of seats in Medical & other technical institutions should be provided.
8	Lower level post (grade-III & IV) in the Govt. should be reserved.
9	The Government can provide rehabilitation to the landless people of minority people.
10	Issue of D. Voters is more painful for the people of Minority in Assam & the matter should be solved.
11	Skill development and employment generation schemes should be taken up.
12	Holding of Awareness Programmes/ workshops on Govt. Acts, Bills, and Schemes meant for the welfare of all Minority groups such as Assam Prohibition of Polygamy Bill, 2025, Prohibition of Child Marriage Act, 2006, Triple Talaq Act, 2019 formally the Muslim Women (Protection of rights on Marriage) Act, 2019, Drugs & Substance Abuse etc. in the University, College, School, Public Places, reputed institutions, Char areas in different locations of the State.
